Each Commissioner is assigned responsibility for specific policy areas by the President. The Commission oversees and implements EU policies by: \* proposing new laws to Parliament and the Council \* managing the EU's budget and allocating funding \* enforcing EU law (together with the Court of Justice) \* representing the EU internationally, for example, by negotiating agreements between the EU and other countries. The Commission is based in Brussels and Luxembourg and has offices (representations) in every EU country and delegations in capital cities around the world.
